

## **Application Criteria for Erasmus+ KA103 Student Mobility:**

- A minimum Cum.GPA of 2.20/4.00 for undergraduates, and a Cum.GPA 2.50/4.00 for graduate students.
- 1 year should be completed successfully before the Erasmus+ Exchange application. ELC students are not eligible to apply.
- Undergraduate students can apply to Erasmus+ program from their 2<sup>nd</sup> year. Graduate and PhD students are able to apply to Erasmus+ program in their first term. If they not have Cum GPA of their current program they can apply with the graduation grade of their previous study cycle. Min GPA requirement is 2.50/4.00.
- The applicants should have KU course load of minimum 30 ECTS (Course load at KU for one term) for the semester in which s/he plans to participate Erasmus Program. Courses taken at the host institution will be recognized by their departments upon successfully completion should be transferred your KU curriculum with grades. (This rule is valid for undergraduate and graduate students)
- Exchange program applicants who are double major students (having completed 15 university credits (30 ECTS) on the application period.), or who are enrolled in two graduate programs should choose one of their majors in order to apply to the program. Students cannot participate in an exchange program from their "minor" studies.
- Participation in Erasmus+ student study mobility more than one time is possible. Students
  can participate the program max. 12 months in each study cycle (undergraduate, graduate,
  PhD).
- The 12 months mobility period includes Erasmus+ student internship mobility. Total mobility period for study or internship program cannot exceed 12 months.
- For the previous participation to Erasmus+ Programs (including study, internship, international credit mobility) at the same study cycle -10 points is deducted. The deduction is not applied for the previous participation in different study cycle Erasmus+ applications.
- In the same study cycle if the students are selected before in previous selection period and cancelled their mobility without any force major, -10 points will be deducted from their following application. When the students cancel their mobility without any force majeure after the deadline of nomination to partner universities, students are not able to apply to any of the exchange programs offered by OIP. There will be a deadline for the cancellation after selection period. If students cancel their mobility before the cancellation deadline no deduction will be applied.

• The applications of the students who have F/W grade or disciplinary penalty are not affected. However students who have F/W grade should be aware and check regulations and departmental procedures that can affect their applications.

## **Selection Criteria:**

Your CGPA 50%

Your TOEFL or IELTS (Taken in 2 years) 50%

## **Mobility Grant:**

Grants will be allocated to selected students in first and second call initially in line with the Erasmus+ program rules after Turkish National Agency announces the Koç University Erasmus+ budget for 2017-2018 Academic. The rest of the budget will be allocated to students who apply in the third call application. Therefore the grant is not guaranteed for any students.
