Business Project (15 ECTS): Students will work in groups and each student will be assigned for a business project at a specific company. Students will be working at those companies once a week under the supervision of a company advisor. There will be no CEMS classes on business project days. Students' business project performances will be evaluated both by their advisors from companies and the academic advisor from Koç University.

*Mandatory Elective Course: As of Academic Year 2023/24, within the coursework required for CEMS MIM & Koç MIM degree, it is compulsory for students to complete (at least) 5 ECTS (cumulative) of 'hard skills' elective courses during the MIM Programme. Please check the Course List to see the hard skill-based courses. The 5 ECTS can be counted cumulatively (i.e., completed over multiple module offerings).

Exams and Grading

Most exams are written, several courses include group and/or individual projects too. Course evaluations can be based on a student's participation in class, coursework, tests, examinations and other evaluations, according to rules defined by the course Instructor in the course syllabus at the beginning of the academic period.
