Application Dates

Applications for the second round of the Erasmus+ Internship program will be open between **05/04/2024 – 27/04/2024, 16:00**. **Late submissions will not be accepted.**

IMPORTANT UPDATE ON THE APPLICATION METHOD AND TECHNICAL ISSUES:

Since there are technical issues on KUAPP about student login, for now, all applications must be entered into only TurnaPortal by the deadline (27.04.2024, 16:00). Students will be contacted later on and advised to complete their applications on KUAPP at a later stage when the KUAPP issue is fixed (This step will be planned and communicated after the deadline)

TurnaPortal System will close with the deadline and it will not be possible to make the application after 27.04.2024, 16:00. All students who wish to apply for this program must enter their applications on TurnaPortal accordingly.

The language score selection issue on TurnaPortal has been fixed.

Internship Quota & Grant Allocation

The estimated quota for the Erasmus+ Internship Second Round for the 2023-24 academic year will be **10 students**, based on the budget given within the Erasmus+ 2023 project. If there are more applications, students not placed in the first 10 will be substituted for grant allocation.

In case there is an additional grant for students, OIP will be announcing it along with the announcement of the results.

Duration of the physical activity	Amount
Up to the 14th day of activity	79 EUR per day
15th to the 30th day of activity	56 EUR per day

Please note that the Erasmus+ Grant for all participants is not guaranteed. Students will be informed about their eligibility and the duration of their grant once the application results are announced. Maximum funding for the Erasmus+ Internship program will be 2 months.
